DIRECTIONS FOR USE

Ground Application (i.e. boom spray, pedestrian application from tank)

Situation	Application Rate	Critical Comments
Turf Management: High Value areas Golf Greens, Bowling Greens, Croquet Lawns, Tennis Courts, High Value Golf Fairways, Premium Sports Fields, Premium Racetracks, Turf Farms, Premium Maintained Lawns	10 L/ha * or 100 mL per 100m ²	Apply in at least 400 - 2500 litres of water per hectare (4 - 25 litres of water per 100m ²). Follow normal irrigation schedule. Apply monthly or as required. * Monthly applications are recommended for best results. Maximiser Elite does not usually require watering in, however turf should be irrigated before next mowing.
Turf Management: Broadacre areas Golf Fairways, Sports Fields, Racetracks, Turf Farms, Reserves & Parks, Polo Fields, Cemeteries, Lawns, General Turf areas	5 – 10 L/ha * or 50 - 100 mL per 100m ²	If applied in very dry conditions (above 28°C), irrigate immediately with 3 mm of rainfall equivalent. To ensure Maximiser Elite is not removed from the treated area prior to soil incorporation, irrigate the treated area before the next mowing with at least 4-6 mm of rainfall equivalent.

GENERAL INSTRUCTIONS

Maximiser Elite is a dual-action soil wetting agent that improves both the penetration, infiltration and retention of water (irrigation and rainfall) in the soil profile.

Soil science research has shown that organic coatings surrounding soil particles inhibit the infiltration of irrigation or rainfall. Hence during high heat stress or drought periods turfgrass can suffer drought injury or death due to the lack of plant available soil moisture.

Maximiser Elite reduces the surface tension of the water molecule, improving the penetration and infiltration of applied irrigation water and rainfall.

Maximiser Elite will

- give water quick and even penetration to ensure limited evaporation and runoff losses.
- ensure uniform distribution, movement and availability of moisture/water in the root-zone.
- alleviate problems associated with water repellency and dry patch (localised dry spot) from hydrophobic soils in all turf areas.
- allow hydrophobic soils to be re-wet and prevent dry patch.
- give even retention of moisture in the soil profile depth/root-zone ensuring plant available moisture to promote uniform turf quality, root growth and root depth whilst improving nutrient availability and uptake.

Maximiser Elite is designed for use on all professionally managed turf areas, examples of such turf areas are listed in the DIRECTIONS FOR USE table. For optimum turf quality Maximiser Elite should be used in conjunction with turf management practices that promote good turf health.

APPLICATION

Ground Application

Boom Sprayers: Spray nozzles should be uniformly spaced and of the same size, and should provide accurate and uniform application. Use spray nozzles that produce a medium spray quality. To ensure accuracy, calibrate sprayer before use and calibrate frequently. Apply at a volume of >400 L of water per hectare. Good even coverage with the spray is essential for optimum results. Observe sprayer nozzles frequently during the spraying operation to ensure that the spray pattern is uniform. Avoid overlapping of spray runs. Avoid application under conditions when uniform coverage cannot be obtained or when spray drift may occur. Shut off spray booms while starting, turning slowing and when stopped.

Pedestrian Application from Tank: Hand nozzle (i.e. fish mouth) should have a uniformed spray pattern. Applicators should calibrate their spraying process to ensure their walking speed, pump pressure and hand nozzle movement (i.e. sweeping action) is even and consistent with the water volumes and the product application rate required.

This product is to be used and applied according to the label directions by professionals (turf managers / greenkeepers) trained in the use of agricultural chemicals, using properly calibrated equipment.

Timing

Apply Maximiser Elite at approximately monthly intervals, beginning at least 1 month prior to the start of the irrigation season (before the onset of dry or heat stress conditions).

A preventive program will alleviate problems associated with the development of dry patch (localised dry spot) and ensure plant available moisture in the soil profile, whilst maximising the use of the water resources, whether that be irrigation water or rainfall.

Application is monthly or as required. Trial work and experience shows more consistent results are achieved with regular applications (i.e. monthly applications). Hence the greater the frequency of application the greater the water use efficiency.

Note: In extreme cases of water repellency and dry patch (localised dry spot) from hydrophobic soils additional applications should be applied between monthly applications, as required.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

Store in the closed, original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. DO NOT burn empty containers or product.

DO NOT get in eyes, on skin, or on clothing. Repeated exposure may cause skin dryness or cracking. Avoid breathing vapours or mists. Use personal protective equipment as directed; Wear overalls, rubber gloves, goggles or face shield. Refer to the Safety Data Sheet (SDS) before use.
